#### 2. The information we collect about you:

When you are a student in St. Mary's National School, Coolfancy, we collect and use your personal data.

The personal data we collect can include information about your identity and contact details; images/photo (including CCTV); family details; admission/enrolment details; previous schools; academic progress; PPS number; special educational needs; nationality; language; religion; medical data; information about behaviour and attendance; information about health, safety and welfare; and other relevant personal data.

On enrolment, we collect the name, address, contact details and other information about your parents/guardians. #### 3. How we use your information and the legal basis:

We use your personal data for purposes including:

to coordinate, evaluate, fund and organise educational programmes;

to comply with our legal obligations as an education body;

to comply with our monitoring and reporting obligations to Government bodies,

to process appeals, resolve disputes, and defend litigation etc.

#### 4. Who we share your information with

We share your personal data with third parties, including other Government bodies.

This includes the Department of Education and Skills, NCSE, TUSLA, An Garda Síochána, HSE, the Department of Social Protection, etc.
